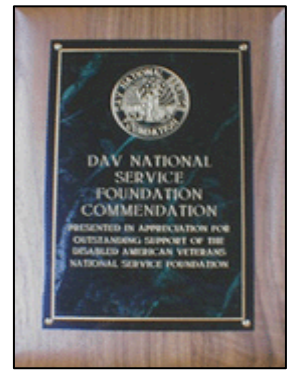


National Service Foundation Commendation
